He was Past President/ Chairman of ASSOCHAM (Association of Chamber of Commerce and Industry),Bombay Chamber of Commerce and Industry, All India Management Association, All India Electrical and Electronics Manufacturers Association, CII (Confederation of Indian Industry) Western Region, amongst others.
